LANARK COUNTY OPP DETACHMENT WEEKLY NEWS
June 1-8, 2020

(LANARK COUNTY, ON) – Between Monday, June 1 and Monday, June 8, 2020 officers from the Lanark County Detachment of the Ontario Provincial Police (OPP) responded to 328 calls for service.

The calls included:

Motor Vehicle Collisions

Total: 20 Including:

Car / Deer: 8

Parking Lots: 5

Single Motor Vehicle off Road (“in ditch”): 1

Impaired Drivers – 1

On June 6, 2020, just after 10:00 p.m., officers from the Carleton Place OPP were called to Lake Avenue East in the Town of Carleton Place regarding a collision. Police attended, spoke to witnesses and conducted their investigation which resulted in the arrest and charge of Calvin CHARTIER, age 21, of Mississippi Mills Township with Operation While Impaired and Operation While Impaired – Over 80. The accused’s driver’s licence was suspended automatically for 90 days, and the vehicle impounded for 7 days. Release was in the form of an Appearance Notice for a scheduled court date of August 17, 2020 at the Ontario Court of Justice in Perth.

Domestic Incidents – 11

Lanark County OPP were called to a domestic incident in Lanark Highlands Township on June 1, 2020 just before 12:30 p.m. A 20 year old female was arrested and charged with domestic assault in relation to her partner. The accused was released from custody on an Undertaking with a scheduled court date of August 17, 2020 at the Ontario Court of Justice in Perth. The victim did not sustain any injuries.

Lanark County OPP were called regarding a stalking incident in the Town of Perth on June 4, 2020 just after 4:30 p.m. Police patrolled and located the person in question and arrested them for harassment. The accused, a 41 year old resident of South

Crosby Township, Ontario was held in custody pending a bail hearing the following day and was further charged with Failure to Comply with Undertaking.

Lanark County OPP were called to a residence in Lanark Highlands Township on June 6, 2020 at 8:30 p.m. regarding a domestic incident between spouses where both sustained minor injuries. Police attended the home and conducted their investigation which resulted in the arrest and charge of a 38 year old resident with two counts of domestic assault. The accused was released from custody on an Undertaking with a scheduled court date of August 24, 2020 at the Ontario Court of Justice in Perth.

A 65 year old resident of Lanark Highlands Township was charged by Lanark County OPP on June 4, 2020, regarding historic incidents between 2011-2020 involving the accused's spouse. Charges include spousal assault, sexual assault and three counts of uttering threats. The male was held in custody pending a bail hearing on June 5, 2020.

Break and Enters – 2

Lanark County OPP were advised on June 3, 2020, of a break & enter to a seasonal residence located on Highway 7 in Tay Valley Township. The incident took place sometime between October 18, 2019 and June 3, 2020. Anyone with information regarding this incident is asked to contact police at 1-888-310-1122.

Lanark County OPP were called to a business on Wilson Street East in the Town of Perth on June 6, 2020, around 12:30 p.m., regarding a break, enter and theft at the location the night prior. Officers attended and conducted their investigation, viewed security footage and collected evidence regarding the approximately \$500 worth of chocolate which had been stolen. Shortly thereafter, three local youth were identified and later spoken to with their parents. The youth, who cannot be identified under the Youth Criminal Justice Act, two aged 16 and one age 17, will have charges diverted.

Thefts – 9

Lanark County OPP were advised of a tool box containing tools valued at approximately \$500 was stolen sometime over the weekend between May 30 to June 1, 2020 from a business located on McVeigh Road in Tay Valley Township.

On June 3, 2020, Lanark County OPP were advised of the theft of power and hand tools and an ice climbing axe from an unlocked shed at a residential property on Herriott Street in the Town of Perth on May 28, 2020. Value of the stolen property is estimated around \$600.

Lanark County OPP were called on June 5, 2020, regarding unauthorized purchases on several different credit cards by a youth residing in the caller's home. A 15 year old male was arrested for Theft Under \$5,000 in relation to the incidents. Charges will be diverted in this matter.

A 17 year old resident of Tay Valley Township was charged on June 7, 2020 with Take Motor Vehicle Without Consent , Failing to Remain and Failing to Report Accident after a collision in the early morning hours. Minor injuries were sustained by the charged driver.

Mischiefs – 10

A 21 year old resident of Ottawa, Ontario has been charged with three counts of domestic mischief after an incident on Norton Street in Mississippi Mills Township on June 6, 2020 around 10:00 p.m. No one was injured in this incident.

Lanark County OPP were called to a residence in Tay Valley Township on June 3, 2020 regarding a threats call. Officers attended and the subsequent investigation resulted in the arrest and charge of Ronald SPENCLEY, age 31, of Tay Valley Township, Ontario, with Uttering Threats to Cause Death or Bodily Harm, Unauthorized Possession of a Firearm and Careless Storage of a Firearm. The accused was further charged with Driving While Under Suspension. The accused was held in custody pending a bail hearing on June 4, 2020 regarding the criminal matters.
