

## Notice of Public Council Meeting Building Department Fees & Forms

**TAKE NOTICE** that the Township of Montague will hold a Public Council Meeting on September 20<sup>th</sup>, 2022, at 6:00 p.m. to consider a by-law to approve the forms and fees associated with the provision of septic services, pursuant to Section 7(6) of the <u>Building Code Act</u>.

Effective October 1<sup>st</sup>, 2022, the Leeds Grenville and Lanark District Health Unit (LGLDHU) will transfer authority for Sewage Systems inspections and permits to local municipalities and it is proposed that the Township adopt the current fee structure now being charged by the LGLDHU as indicated in the chart below. Potential adjustments to the fee structure will then be considered during the Township's regular annual budgeting process.

A report was provided to Council on August 9<sup>th</sup>, 2022, to appoint a primary septic inspector and establish fees associated with the provision of septic services, the latter of which would take effect as of October 1<sup>st</sup>, 2022. A copy of the report and by-laws are available for public viewing on the Township's website at <a href="https://www.montaguetownship.ca">www.montaguetownship.ca</a> and can be found within the Council agenda package from the August 9<sup>th</sup>, 2022, Council Meeting.

The forms required to facilitate the provision of septic services will be brought to the September 20<sup>th</sup>, 2022, Public Council Meeting for review and consideration.

All interested parties are invited to attend the Public Meeting in person or virtually, through the Township's YouTube channel, to provide comments.

- Note #1: The Ministry of the Environment will be responsible for sewage works where the design capacity
  is in excess of 10,000 litres/day under the Ontario Water Resources Act.
- Note #2: Tertiary Treatment Systems (Level 4 Treatment) are Ecoflo, Eljen, Waterloo Biofilter, ATL, EnviroSeptic, Norweco, and Biomicrobics and require Maintenance Agreements upon installation completion.
